

TOWN OF FORT MACLEOD

BYLAW NO. 1838

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF FORT MACLEOD FOR THE 2016 TAXATION YEAR

Whereas, the Town of Fort Macleod has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on *May 17, 2016* ; and

Whereas, the estimated municipal expenditures and transfers set out in the budget for the Town of Fort Macleod for 2016 total \$9,463,921; and

Whereas, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$5,874,282, and the balance of \$3,589,639 is to be raised by general municipal taxation; and

Whereas, the requisitions are:

Alberta School Foundation Fund (ASFF)	\$631,135

Whereas, the Council of the Town of Fort Macleod is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

Whereas, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000; and

Whereas, the assessed value of all property in the Town of Fort Macleod as shown on the assessment roll is:

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the Town of Fort Macleod, in the Province of Alberta, enacts as follows:

- I. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Town of Fort Macleod:
