

TOWN OF FORT MACLEOD

IN THE PROVINCE OF ALBERTA

BYLAW NO. 1894

Being a Bylaw of the Town of Fort Macleod in the Province of Alberta to amend Bylaw No. 1836, being a bylaw respecting business, business activities and persons engaged in business.

WHEREAS the Municipal Government Act, Chapter M26.1, RSA and amendments thereto, provides a municipality may pass bylaws for municipal purposes respecting businesses, business activities and persons engaged in business;

AND WHEREAS Council now deems it expedient to provide the following amendments to Bylaw 1836, the "Business License" Bylaw.

NOW THEREFORE THE MAYOR AND COUNCIL of the Town of Fort Macleod duly assembled enact as follows:

1. The Town of Fort Macleod Business License Bylaw #1836 shall be amended as follows:

Add: 5.1.e.e. – For business where more than one salesperson conducts business within the Town of Fort Macleod, such as, but not limited to: Avon, Tupperware, Scentsy, only the regional manager is required to obtain a business license.

2. Add: 6.5. – (if applicable).

3. Amend: 13.1.b.

- a. From: When the transfer is for a change of civic address from one Business Premise to another for the same Licensee and Business with the exception of a Home Occupation License.
- b. To: When the transfer is for a change of civic address from one Business Premise to another for the same Licensee and Business (with the same land use designation (zoning)) with the exception of a Home Occupation License.

4. Amend: 13.5.

- a. From: Any person desiring to obtain a transfer of any License issued pursuant to this bylaw, shall be required to pay a processing fee as outlined in Schedule "A".
- b. To: Any person desiring to obtain a transfer/change of information of any License issued pursuant to this bylaw, shall be required to pay a processing fee as outline in Schedule "A".
